 - an existing beneficial owner of shares in the Company and/or any of its subsidiaries;

 - an associate (as defined in the Listing Rules) of any of the above; or
 - have been allocated or have applied for or have indicated an interest in any Placing Shares under the Placing.

B. If you are a nominee

C. Effect of completing and submitting this Application Form

By completing and submitting this Application Form, you (and if you are joint applicants, each of you jointly and severally) for yourself or as an agent or a nominee on behalf of each person for whom you act:

Determination of Offer Price and Allocation of Public Offer Shares

The Offer Price is expected to be fixed on or about Tuesday, 18 December 2018. Applicants are required to pay the maximum Offer Price of HK\$1.25 for each Public Offer Share together with 1% brokerage, 0.0027% SFC transaction levy and 0.005% Stock Exchange trading fee. If the Offer Price is not agreed between the Company and Sole Bookrunner (acting for itself and on behalf of the Underwriter) on or before Tuesday, 18 December 2018, the Share Offer will not proceed.

Applications for Public Offer Shares will not be processed and no allotment of any Public Offer Shares will be made until the application lists close.

The Company expects to announce the final Offer Price, the indication of the level of interest in the Placing, the level of applications under the Public Offer and the basis of allocation of the Public Offer Shares on Friday, 28 December 2018 on the website of the Hong Kong Stock Exchange at www.hkexnews.hk and the Company's website at www.yield-go.com. The allocation of Offer Shares between the Public Offer and the Placing is subject to adjustment as detailed in the section headed "Structure and Conditions of the Share Offer – The Public Offer – Re-allocation" in the Prospectus.
