PROFIT WARNING

This announcement is made by Yield Go Holdings Ltd. (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09(2) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board (the “**Board**”) of directors of the Company wishes to inform the shareholders of the Company (the “**Shareholders**”) and potential investors of the Company that, based on the preliminary review of the unaudited consolidated management accounts of the Group, the Group is expected to record a decrease in unaudited net profit of approximately 60% to 80% for the six months ended 30 September 2019 (the “**Period**”) as compared to unaudited net profit of approximately HK\$13 million for the six months ended 30 September 2018.

Such expected decrease was mainly attributable to (i) the decrease in revenue as a result of the decrease in number of sizeable projects undertaken during the Period; (ii) the decrease in gross profit margin due to the increase in the Group’s overall construction costs; and (iii) the adoption of a more competitive project pricing strategy by the Group in response to intense market competition during the Period.

The Group is still in the process of finalising the unaudited interim results for the six months ended 30 September 2019. Shareholders and potential investors should note that the information contained in this announcement is only based on a preliminary assessment by the Board with reference to the unaudited consolidated management accounts and information currently available to the Board, which are subject to further adjustments, have not been audited or reviewed by the auditor of the Company, nor have been confirmed by the audit committee of the Company. The actual results of the Group for the Period may be different from what is disclosed herein. Details of the Group’s financial information for the Period will be disclosed in the interim results announcement of the Group, which is expected to be published on 29 November 2019.

Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.
